The 2008 UFE results will be released on **December 5, 2008**. In collaboration with the four Western Provincial Institutes, CASB has developed the following process and timetable for release of results to candidates, CA training offices and the public:

8:00am MST: A list of students, by UFE candidate number, and the pass/fail results will be posted on the CASB website, [www.casb.com](http://www.casb.com). Each provincial institute will post a similar list applicable to its province or include a link to CASB on its website.

9:00am Local Time: Candidates can pick up results envelopes at designated locations across the region. A list of pick up locations is attached.

9:00am Local Time: CA Training Offices can pick up results envelopes at designated locations across the region. A list of pick up locations is attached.

10:00am MST: Only candidates residing outside the immediate distribution point area may contact CASB offices for oral confirmation of the posted results.

11:00am MST: A list of the names of successful candidates will be posted on the CASB and Provincial Institutes website.

3:00pm Local Time: CASB will send individual student and CA Training Office envelopes not yet picked up by regular ground mail.

Students who do not work in a city where there is a distribution location will have their transcript mailed to their preferred address, unless otherwise notified.
